## The following rules and fees apply to daytime and overnight docking:

### **Rules:**

At Bushnell Basin Docks:

Please register with the dockmaster (Marathon Gas Station\*) and promptly pay the posted fee for planned length of stay. If no dock master is on duty at the time of your arrival, please complete the registration form and insert payment envelope in lockbox at the dock master's station.

At Perinton Park docks please register at Town of Perinton if staying overnight.

Day use is free at all Town of Perinton docks.

Stays may be limited to 7 days, depending on availability of space.

Boats may not be locked to any dock area or left abandoned.

Boats may be moved at the dockmaster's and/or Town of Perinton's discretion.

The Town of Perinton and dockmaster are not responsible for the security of any boats or personal possessions.

Please be considerate of others by minimizing noise, disposing of trash in nearby receptacles, and respecting others' property.

By docking at Town of Perinton docks, you agree to adhere to the rules, as enforced by Town of Perinton staff and the Monroe County Sheriff's Department.

Dockmasters are on duty daily during Marathon business hours and provide information, directions, canal maps and other assistance as needed.
