2021/22 SCHOOL TAX COLLECTION

I, the undersigned, having received the TAX WARRANT for the collection of School Taxes for the present fiscal year, will receive such taxes on property situated in the Town of Perinton for the following school districts:

Fairport Central School District
East Rochester Union Free School District
Penfield Central School District
Pittsford Central School District
Victor Central School District

School Tax Collection locations, and times:

- Town of Perinton, Town Clerk/Tax Receiver's Office – 1350 Turk Hill Road – Monday through Friday, 9:00am until 5:00pm
- Town of Perinton, Tax Drop Box – Located in the front of the Town Hall Entrance – Open 24 Hours (Must adhere to all deadlines and penalties)
Full Payments – September 1, 2021 through November 1st, 2021
First Installment Payments **ONLY** – September 1, 2021 through September 15, 2021

Payment Schedule:

Full Payments

- Full payments are due October 1st (interest free)
- Full payments made between October 2nd - November 1st must include a 2% penalty
- All unpaid taxes will be turned over to Monroe County starting November 2nd

First Installment Payments **ONLY**

- First Installment payments are due September 15th
- First installment payments made between September 16th – 20th must include 1% penalty.
- Installments are no longer an option after September 20th.
- Second and Third installments **MUST BE** mailed or paid in person at the Monroe County Treasurer's Office, P.O. Box 14420, 39 West Main Street, Rochester, NY 14614.

In the event that the due date falls on the weekend or holiday, payment will be accepted the next business day without penalty or additional interest due.

Checks for the EXACT amount of the tax bill will be accepted. Instructions for payment are included on the back of the first page of the tax bill. The corresponding payment stub must accompany payment.

- All Full/1ST installment payments should be made payable to JENNIFER A. WEST, RECEIVER OF TAXES
- US postmark is used to determine the payment date for all payments being mailed. Payments received postmarked after the due date will be charged interest
- On-line bank payments are discouraged, as they arrive in office with no U.S. postmark and there is no guarantee that the payment will be delivered to our office by the due date
- Credit Card payments can be made at www.monroecounty.gov. A fee equaling 2.75% of the total amount paid for any transactions greater than \$100, will be charged by the credit card company when paying by credit or debit. Payments of \$100 or less will be charged \$2.75
- Electronic Check payments can be made at www.monroecounty.gov. A sliding scale fee is charged based on the amount of payment

Any taxpayer paying their taxes directly and DOES NOT receive their tax bill by September 7, 2021 should contact the Tax Office at 223-0770 or visit the Monroe county website at www.monroecounty.gov for a printed copy.
