

**TOWN OF PERINTON**  
**2025-26 SCHOOL TAX COLLECTION**

I, the undersigned, having received the TAX WARRANTS for the collection of School Taxes for the present fiscal year, will receive such taxes on property situated in the Town of Perinton for the following school districts:

Fairport Central School District  
East Rochester Union Free School District  
Penfield Central School District  
Pittsford Central School District  
Victor Central School District

**School Tax Collection locations, and times:**

- Town of Perinton, Tax Office – 1350 Turk Hill Rd, Fairport, NY 14450 – Monday - Friday, 9AM - 5PM
- Town of Perinton, Tax Drop Box – Located out front of the Town Hall Entrance – Open 24 Hours  
(Must adhere to all deadlines and penalties)

**Payment Schedule:**

Full Payments

- **Full payments are due October 1<sup>st</sup>** (interest free)
- Full payments made between October 2<sup>nd</sup> – October 31<sup>st</sup> must include a 2% penalty
- All unpaid taxes will be turned over to Monroe County Treasurer starting November 1<sup>st</sup>

First Installment Payments **ONLY**

- **First Installment payments are due September 15<sup>th</sup>**
- First installment payments made between September 16<sup>th</sup> – 20<sup>th</sup> must include 1% penalty.
- Installments are no longer an option after September 20<sup>th</sup>.
- Second and Third installments **MUST BE** mailed or paid in person to the Monroe County Treasurer's Office, P.O. Box 14420, 39 West Main Street Room B-2, Rochester, NY 14614.

**\*If the due date falls on the weekend or holiday, payment will be accepted the next business day without penalty or additional interest due.**

**Payment Options:**

- By check or cash in person at the Town Tax Office (Monday - Friday, 9AM - 5PM)
- By check via mail (receipt date determined by **U.S. postmark only**)  
\*Online Bank Payments – Online bank payments arrive in office by paper check and with no US postmark so we must go by the day it arrives in office. Banks discourage the use of online banking for tax payments because they cannot guarantee your payment will be delivered to our office by the due date. **If you utilize online banking, you do so at your own risk**
- By check in the Town Tax Drop Box located out front of the Town Hall entrance – open 24 hours (**Must be in tax drop box by end day on tax due date to ensure no additional penalty or interest**)
- By credit card online at [www.monroecounty.gov](http://www.monroecounty.gov) - A fee equaling 2.75% of the total amount paid for any transactions greater than \$100 will be charged by the credit card company when paying by credit or debit card. Payments of \$100 or less will be charged a flat fee of \$2.75
- By electronic check online at [www.monroecounty.gov](http://www.monroecounty.gov) – A sliding scale fee is charged based on the amount of payment

**All Full/1<sup>ST</sup> installment payments should be made payable to  
DEBBIE D. BROWN, RECEIVER OF TAXES**

Checks for the **exact amount only** will be accepted. Instructions for payment are included on the back of the first page of the tax bill. The corresponding payment stub must accompany payment.

Any taxpayer paying their taxes directly and **DOES NOT** receive their tax bill by September 5, 2025, should contact the Tax Office at 223-0770 or visit the Monroe County website at [www.monroecounty.gov](http://www.monroecounty.gov) for a printed copy.
