NOTICE IS HEREBY GIVEN, that a petition, pursuant to General Municipal Law §704, has been received by the Town Board of the Town of Perinton, Monroe County, New York (the “Town”) and the Board of Trustees of the Town/Village of East Rochester, Monroe County, New York (the “Village”), for the annexation of the following described territory situated in the Town to the Village:

a vacant and unoccupied portion of Town Lot 55, Township 12, Range 4 referenced in Liber 10958 of Deeds at page 168, identified as tax account number 139.13-03-20 containing .767 of an acre of land, more or less, on the east side of Lincoln Mills Road, north of East Linden Avenue,

and adjacent to the Town/Village of East Rochester.

NOTICE IS FURTHER GIVEN, that on the 23<sup>rd</sup> day of June, 2021, at 7:30 o'clock in the evening of that day, a joint hearing upon such petition will be held by the Town Board of the Town and the Village Board of Trustees of the Village of East Rochester, via StarLeaf. Objections based on any of the grounds set forth in General Municipal Law §705(1)(a), (b), (c) and (d) shall, in addition to oral testimony thereon, be submitted in writing.
