ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Town of Perinton Spring Lake Trail Project** will be received, by the **Town Clerk**, at the office of the **Town of Perinton, 1350 Turk Hill Road, Fairport, NY 14450**, until **11:00 a.m.** local time on **March 9, 2023**, at which time the Bids received will be **publicly** opened and read aloud.

The Project consists of constructing approximately 2,100 LF of stone dust trail that follows an existing informal footpath between Spring Lake Park in the Town of Perinton and Channing Philbrick Park in the Town of Penfield. Approximately 300 LF of stacked heavy stone armament will be installed to provide streambank stabilization along a heavily eroded portion of Irondequoit Creek. The project also includes construction of a small timber framed structure (5'-11" wide with 4 – 10' spans) along the trail route to span an overflow channel. Due to challenging terrain, access to the project site will be via a temporary creek crossing constructed in accordance with NYSDEC and USACE permit requirements in the location shown on the plans. All permits required for this project are already in place.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, as indicated in the Bid Form.

This is a federal-aid contract subject to the approval of the Federal Highway Administration (FHWA) and the New York State Department of Transportation (NYS DOT). There is a 5% DBE goal that has been established for this contract (as a percentage of the total contract bid amount). There are no M/WBE/SDVOB requirements or preferences contained in this contract. EEO goals in accordance with FHWA 1273 apply and have been established as follows: Minority – 5.3% and Female – 6.9%. Contract will require the use of Equitable Business Opportunity (EBO) software available from NYS DOT.

A Pre-Bid Conference will be held 9 a.m. February 23, 2023 at the Town of Perinton Department of Public Works office located at 100 Cobb's Lane, Fairport NY 14450.

The Issuing Office for the Bidding Documents is: **The Perinton Town Clerk's Office, located at 1350 Turk Hill Road, Fairport NY 14450**. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of **9:00 a.m. and 4:30 p.m.**

Bidding Documents also may be examined at Perinton DPW, 100 Cobbs Lane, Fairport, New York 14450 on Mondays through Fridays between the hours of 8:00 a.m. and 3:30 p.m.; at plan rooms, or online through internet based construction information subscription services.

Bidding Documents may be obtained from the Issuing Office during the hours indicated above. Bidding Documents are available on a USB Flash Drive that contains portable document format (PDF) files for a non-refundable charge of \$20.00 for each set, payable to Town of Perinton. A paper copy of the Bid Form will be provided along with the Flash Drive. No other print documents will be issued. Bidder is responsible for costs associated with printing any Digital Documents. In order for a bid to be considered valid, Bid Documents must be obtained from the Issuing Office only. Bidding Documents obtained from any other source are for examination only, are not considered complete, and are not valid for bidding purposes.

Upon request and receipt of the document fee indicated above, plus a separate non-refundable shipping charge of \$20.00 payable to the Issuing Office, the Issuing Office will transmit the Bidding Documents via delivery service.

In lieu of the shipping charge, prospective bidders may pick up Bidding Documents themselves at the Issuing Office, or they may ask to have the documents shipped on their own account number. Prospective bidders having Bidding Documents shipped on their own account number must provide their account number, desired method of shipping (overnight, next afternoon, etc.) and a statement permitting the Issuing Office to use their account number to ship documents to them. Requests for Bidding Documents that are not accompanied by the required letter will be returned.

When requesting Bidding Documents, prospective bidders must include a letter stating their name, firm's name, shipping address (no P.O. Box numbers), telephone number, email address, fax number (if any), name of project for which they are requesting Bidding Documents, intended contract, amount of money enclosed, and, if applicable, check numbers.

The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Town of Perinton nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

The Town of Perinton, Monroe County, New York, reserves the right to reject any or all bids, or to waive any informalities, or to make an award to other than the low bidder. It further reserves the right to limit the amount of the award.

Attention of the bidders is particularly directed to the requirements of the conditions of employment to be observed and minimum Wage Rates to be paid under the Contract.

The Town of Perinton does not discriminate on the basis of handicapped status in admission or access to, or treatment or employment in, its programs and activities.

Bid security shall be furnished in accordance with the Instructions to Bidders.
