**WHITNEY ROAD WEST SIDEWALK REPLACEMENT**

**Town of Perinton** (Owner) is requesting Bids for the construction of the **Whitney Road West Sidewalk Replacement**. In accordance with Section 103 of Article 5-A of the General Municipal Law, sealed Bids for the construction of the Project will be received at the office of the **Town of Perinton, 1350 Turk Hill Road, Fairport, New York 14450**, until **June 21, 2024**, at **11:00 AM** local time. At that time the Bids received will be publicly opened and read.

The project consists of the installation of approximately 1,650 Linear Feet of Concrete Sidewalk. The Project includes removal of existing asphalt sidewalk, excavation, installation of subbase material, adjustment of miscellaneous utilities (valve boxes/services, manhole frame and covers, etc.), and installation of new concrete sidewalk. Work also includes removal of one existing curb cut, and installation of one new curb cut and ADA sidewalk ramp, driveway restorations, and site grading and restoration between the edge of roadway and new sidewalk, and behind the newly installed sidewalk. The project also includes all necessary temporary erosion control and maintenance and protection of vehicular and pedestrian traffic.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, as indicated in the Bid Form. **Project has an expected duration of 90 days.**

Bidding Documents will not be available for purchase directly from MRB Group or the Owner (Town of Perinton).

The Town of Perinton, Monroe County, New York, reserves the right to reject any or all bids, or to waive any informalities, or to make an award to other than the low bidder. It further reserves the right to limit the amount of the award.

Attention of the bidders is particularly directed to the requirements of the conditions of employment to be observed and minimum Wage Rates to be paid under the Contract.

Minority and Women Business Enterprises and Section 3 firms are encouraged to participate.

This project is funded under the Community Development Block Grant (CDBG) Program, as administered by the Monroe County Department of Planning and Development and is subject to the provisions of Section 3 of the HUD Act of 1968, as amended and other CDBG Program regulations. Prospective bidders should review the CDBG included in the contract documents.
